All projects funded under the Mississippi Water Pollution Control Revolv-

ing Loan Fund Program undergo a review to determine whether the proposed project will have a significant impact on the environment. In making this determination, the Department assumes that all of the facilities and actions recommended in the facilities plan will be implemented. The facilities plan for this project is entitled "2024 Wastewater System Improvements" dated March 2025 and prepared by Cook Coggin Engineers, Inc.
The proposed project includes the rehabilitation of five (5) lift stations, the cleaning/CCTV/smoke testing of approximately 20,000 linear feet (LF) of 8" gravity sewer lines, and 15,000 LF of post construction TV inspections. The project also includes the replacement of approximately 11,100 LF of 8" sewer line segments, the lining of approximately 5,000 LF of 8" gravity sewer, and 45 EA of 8" point repairs all at different depth cuts. Further, the project includes the rehabilitation/replacement of approximately 230 EA and 10 EA manholes respectively, 50 vertical feet (VertFt) of manhole extra depth, 300 VertFt of manhole wall sealing, the inspection of 100 EA manholes and other appurtenances. The estimated project cost is \$5,037,000, and the anticipated loan amount is \$1,037,000 (with an anticipated subsidy amount of \$4,000,000). The location of the proposed project is within the town corporate limits and surrounding areas.
The Mississippi Office of Pollution Control has determined that the proposed project meets the criteria for receiving a categorical exclusion from further environmental review. However, this determination can be revoked if significant adverse information becomes available.
